RENTAL FORM

Each item of rental equipment that you need for your trip is an important element in making a success of your mountain journey. To help us get to you exactly what you need, it is essential that you fill out this form precisely and completely. We prefer to receive this form 60 days prior to your departure. If you are registering less than 60 days before your trip, please handle this with great urgency.

This form is used for all U.S. programs except those in Washington and for all international programs.

RENTAL AGREEMENT - Please read carefully before signing below.

1. I agree that I will return the equipment being rented to me by American Alpine Institute (AAI) in good condition at the end of the rental period, or that otherwise I will pay AAI for the cost of repairing damaged gear and of replacing rental gear that is lost, stolen, damaged or not returned to AAI. I agree to return this gear within one week of the ending date of the rental or pay additional, weekly rental fees.
2. I agree that charges for the rental of the gear plus any additional charges as described in #1 above should be charged to my credit card which I have listed on the reverse side of this form.
3. I agree to use the equipment being rented only for myself personally and for the mountaineering, backpacking, and camping purposes for which it was designed.
4. I recognize the hazards and the risk of injury or death in the use of the equipment and take full responsibility for my own safety while using it.
5. I agree to use this equipment only after receiving or while receiving instruction in its proper use.
6. In consideration of the service provided by AAI in renting this gear to me, I assume the risks involved and absolve AAI, its directors, officers, and employees from any and all claims, damages, liability, expense, or cost of any kind that may arise out of its use. I hereby voluntarily release, hold harmless, and indemnify AAI from any claims and demands which are connected with my rental of this gear. The terms herein serve also as a release of liability and an assumption of risk by my heirs, executors, administrators, and members of my family.
7. If AAI or any of its agents incurs attorney's fees or costs to enforce this agreement (whether or not a suit is brought) I agree that AAI shall be entitled to recover from me all such fees and costs, and I agree that my use of the gear and this agreement shall be solely subject to and governed by the laws of the State of Washington and applicable U.S. federal law, and I agree to submit irrevocably to the jurisdiction and venue of the Superior Court of the State of Washington for Whatcom County, and I waive any rights of removal.
